That, coupled with a long history in the United States, enables Total to exceed the expectations of our customers and partners," he said.

Burnett will also serve as the Country Representative for the 18 Total companies operating in the United States. The Total affiliated companies have a combined workforce of more than 5,900 people in the upstream, downstream and specialty chemicals industries.
